### **Constitution Change**

Mark Doherty gave an overview as to why we are looking at reviewing the constitution and why we need to do it.

- Decision to pull all the operational info out of the constitution and into By-Laws
- Used SLS NSW constitution as a template for CHSLSC.
- Keeps it simple
- Aligns us to SLS NSW
- Makes it easier, to make operational changes to the club
- Structural change to how the club is run Reduces workload on Committee, sub committee's aligned underneath.

Major difference between constitution and bylaws:

- constitution needs a SGM requiring a quorum of 15 people.
- Bylaws can be change via Executive Management Meeting, currently with Quorum of 4, in new constitution, bylaw will need a majority vote to change.

Jack Saunders, voiced concerns over structure of Bylaws /constitution of membership and life members and awards and how the process would work.

MD explained new and old structure will remain the same, and directed JS to organisation structure chart.

#### **Action Item - Surf Club Building**

Presentation given on background, current situation and where we are financially on the build on the club. By Club Vice President – John Reid

Committee is seeking member approval to borrow up to \$100,000. This allows partial completion of the upper and mid levels of the building.

- Toilets allow training & meeting room to be used
- Office & training room functional.
- Current cashflow allows us to just finish contract, including useable downstairs toilets and change rooms.
- Another option was to borrow up to \$300k to do a basic fit out of upstairs but Executive feels it is not the best use of funds or financially viable.
- Funds are coming from a club member, who wishes to remain anonymous.
- \$100k line of credit as such only pay interest on what we have borrowed. Reasonable rate and it is something at which we can afford to repay

Lease, council made decision re commercial entity on the site. Allowing us to be able to down the line rent current club space.

## Vote:

The members attending the meeting voted, and it was a vote of 26. (35 attendee's) Club will move forward with borrowing funds.
